ARTICLES OF INCORPORATION
OF
ALPHA LOGGING AND WOOD PROCESSING, INC.

WE, the undersigned, for the purpose of forming a Corporation pursuant to the provisions of the Liberian Business Corporation ACT, do hereby make, subscribe, acknowledge and file into the office of the Minister of Foreign Affairs, this INSTRUMENT for the purpose, as follows:

ARTICLE I

The name of the Corporation (hereinafter referred to as the "Corporation") shall be: "ALPHA LOGGING AND WOOD PROCESSING, INC., Lara Building, Randall Street, Monrovia, Liberia

ARTICLE II

The purposes for which the Corporation is formed are as follow:

- a. To engage in any legal transaction of Real Estate management and Consultancy within the confines of the Republic of Liberia;
- b. To engage in logging and wood processing activities;
- c. To engage in the importation and sales of general merchandise;
- d. To engage in transportation services;
- e. To engage in mining of gold and diamond, and also the buying and selling;
- f. To engage in loan services;
- g. To engage in communication services;
- h. To own, hold, rent, lease, manage, improve, exchange, buy and sell real estate property, collect rent and do a general real estate;
- i. To engage in entertainment services;
- j. To engage in any other lawful acts or activities for which Corporations may now or hereafter engage in under the laws of Liberia.

ARTICLE III

The names and post office address of the subscribers of these Articles of Incorporation and the number of shares of the Corporation are as follows:

ARTICLE IV

The Resident Agent of the Corporation and the address of the Resident Agent Clearance Tay, P.O. Box 519, Lara Building, Randall Street, Monrovia, Liberia

ARTICLE V

The maximum number of shares of stock that a Corporation is authorized to have outstanding at any time is ONE HUNDRED (100) SHARES with out par value

ARTICLE VI

The Corporation shall have perpetual existence.

ARTICLE VII

The initial capital with which the Corporation will commence operation shall not be less than one Hundred-Fifty Thousand (\$150,000.00) Dollars.

ARTICLE VIII

The Corporation shall have every power which a Corporation now or hereafter organized under the Liberian Business Corporation Act may have.

ARTICLE IX

The first Board of Directors of the Corporation shall be elected at the first meeting of the shareholder(s), and said Board of Directors shall consist of not less than 3 (three).

ARTICLE X

The Corporation has the right to sue and or be sued.

ARTICLE XI

The Corporation shall indemnify any of its Directors, Officers or any person who may have served at its request unless the acts of Directors, officers and person wherein performance of corporate business and authorized by the Corporation.

ARTICLE XII

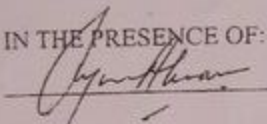
